Course Description

This course is designed for physical therapy students who need a basic understanding of the major ethical issues confronting the practices of profession. This course discusses the contribution of ethics to physical therapy profession.

Course Objectives

This course is designed to educate, promote and facilitate ethical behavior by physical therapists. The students in the end this course should be familiar with the foundations and particular approach of physical therapy ethics. By the end of this course the student should be able to recognize the importance of ethical decision and its effects on the clinical situations and behaviors.

Learning Outcome

- 1) Define the meaning of Ethics and explain the various theories that promote ethical behavior.
- 2) Define the parameters of informed consent
- 3) Define the ethical decision making model
- 4) Define conflict of interest and identify situations that demonstrate it
- 5) Define the medical ethics and how to demonstrate in medical situations
- 6) Differentiate between appropriate and inappropriate relationships
- 7) Apply the ethical decision making model to clinical situations to determine appropriate professional behavior
